A pilot may plot a course, but it takes a team of people – mechanics, engineers, ground crew – to make the airplane fly and reach its goal. There is rarely only one right way to get from point A to B. Taking many viewpoints and ideas into account ensures that when a solution is reached, it works for everyone and that we all reach our destination at the same time. We've become adept at making course corrections the last two years, and we have learned the importance of flexibility and resilience. As we work back to our new normal, those skills will continue to be invaluable.

I chose a quote from Amelia Erhardt to represent my aspirations for the next two years. "Is what we undertake reckless? Maybe....but what do dreams know of boundaries?".

I ask each of you to think about your dreams for this administration, setting aside the boundaries we impose on ourselves, and consider how you can use the power of lift to give your dreams flight. I'm excited to see what we can achieve over the next two years if we all use the power of lift to make our dreams a reality.

MISSION STATEMENT

GFWC-Washington State is part of the General Federation of Women's Clubs (GFWC) which was established in 1890. The General Federation of Women's Clubs is an international women's organization dedicated to community improvement by enhancing the lives of others through volunteer service.

EXECUTIVE SUMMARY

A strategic plan is a working document that guides and strengthens the activities of an organization. Goals and strategies to achieve them enable the organization to plan effectively for the future.

This 2010-2014 Strategic Plan identifies five major GFWC-WS areas of concern (not in any order of priority). It is organized with clear vision statements of each concern, objectives that support the vision and specific action plans for achieving each objective.

Focusing on the achievement of objectives within these five areas of concern will guide our membership toward the realization of the GFWC vision of providing its members opportunities to: serve their communities effectively though organized activities, develop leadership skills, participate in continued learning and enrichment, and cultivate lasting friendships.

STATEMENT OF RESPONSIBILITY

The GFWC-Washington State (GFWC-WS) Strategic Planning Committee (comprised of the elected state officers) is responsible for strategic planning and the regular review and refining of the Plan.

It is the responsibility of every GFWC-WS member to support and promote the visions and objectives as stated in the 2010-2014 Strategic Plan and adopted by the Board of Directors.

- State and district officers and chairmen design activities and materials that help to carry out the visions and objectives of the Plan.
- Clubs learn about and participate in activities that further the visions and objectives of the Plan through attendance at meetings and reading state and national materials.

AREAS OF CONCERN

The GFWC-WS 2010-2014 Strategic Plan focus areas are:

- Membership
 - 1. Instill pride and purpose in all GFWC-WS members.
 - 2. Strengthen our existing clubs by retaining existing members and being open to new members.
- Leadership
 - 1. Utilize our LEADS graduates by providing them with continuing leadership opportunities and providing them with GFWC leadership tools.

- Communication and GFWC Awareness
 - 1. Support the GFWC goal of building brand identity through continued awareness.
- Programs, Projects, Activities
 - 1. Encourage clubs in the state to participate in GFWC programs and projects with special awareness of GFWC Partner organizations and Domestic Violence Awareness.
- Finances
 - 1. Work to increase the financial stability of GFWC-WS VISION: Every club and district increases membership.
- Assist each club and district to develop a membership plan that includes retention of current members as well as recruitment and orientation training of new members.
- Establish a task force to work with leadership for the purpose of starting new clubs.
- Encourage state and district leaders to visit each constituent club at least once during their administration.
- Encourage clubs and districts to honor a Clubwoman of the Year.
- Promote club and district participation in the GFWC Jennie award.

GFWC-WS VISION: Ongoing leadership training for members at all state and district meetings.

- Increase the number of club applicants for participation in the GFWC LEADS program.
- Assist districts to plan programs and workshops to inform and inspire members.
- Provide worthwhile programs and workshops at all state meetings.
- Encourage clubs and districts to provide \$\$ For Delegates attending state meetings.
- Provide advanced training for members serving in leadership roles at all levels.
- Use GFWC-WS communications to regularly address various aspects of leadership.

GFWC-WS VISION: Improve communication and increased GFWC Awareness.

- Develop a GFWC-WS membership database to strengthen communication on all levels.
- Provide training to increase the number of club websites and members who use email.
- Use GFWC-WS communications to regularly address topics of value to the Strategic Plan.
- Provide GFWC-WS materials that are easily read and understood.
- Include GFWC in all club names and promote use of emblematic apparel or other items.
- Help members to realize the value of their GFWC membership and its rich history.

GFWC-WS VISION: More clubs reporting their great programs, projects and activities.

• Provide clubs and state chairmen with training and tools to make reporting easier.

- Design categories and recognition to provide equitable competition for state awards.
- Plan creative awards presentations that will celebrate the best with fun and enthusiasm.
- Help provide new project ideas with communications, panel discussions and workshops.
- Work to provide larger scholarships and monetary awards.

GFWC-WS VISION: Better use of resources and member awareness of a realistic financial plan.

- Encourage increased monetary support of the endowment and educational scholarships.
- Reduce expensive print media and postage costs by using email whenever possible.
- Clearly define periodic income, expense, and loss or gain of investments in reports.
- Encourage club and district support of those serving on state, regional or GFWC levels.
- Increase member awareness of the importance of their attendance and room/meal participation at state meetings.

GFWC-WS President-elect District Information and Responsibilities

GFWC-WS President-elect is the counselor to the District Presidents. Districts, as defined in our by-laws, play a key role in keeping the communication open between the state and member clubs. District Presidents are members of GFWC-WS Executive Committee, and the State Board of Directors. District and Club Presidents should make every effort to attend all state meetings, since they are representatives for their districts and clubs. District by-laws should conform to the GFWC-WS by-laws. Districts should meet at least twice a year to conduct business, share information and build relationships and friendships.

Responsibilities of a District President:

• attend all GFWC-WS meetings, workshops and conventions, and sit on the

GFWC-WS Executive Committee and Board of Directors.

- appoint chairmen and committee members as required by district by-laws.
- provide a written/verbal report of District activities at each state meeting.
- distribute materials to District chairmen and clubs in a timely manner.
- plan District meetings and encourage all club women to attend.
- create and distribute Calls to all District clubs and District Board members.
- provide a courtesy invite and Call to the State Executive Committee members

(Five elected officers and five District presidents.)

• invite the current State President to speak or provide a workshop at a District meeting.

• when endorsing a candidate for State office, be prepared to present the endorsement at the election year State Convention.

• provide a written report of your District accomplishments (not clubs) to the

State President by February 15 for inclusion in her report to Headquarters.

In addition to above state duties, District Presidents should make themselves available to all

clubs in their district for programs and workshops; invite State Board members to District

meetings; lead by example and also encourage clubs to participate... enter contests, write

reports, submit newsletter articles, and visit our GFWC-WS webpage often.

GFWC Signature Program: Domestic Violence and Sexual Assault Awareness and Prevention

Domestic Violence of all areas is a serious problem everywhere. Have a speaker from your Police Department, or from the agencies that help the women and children to educate your members and to learn what you can do in your community to help the victims.

The General Federation of Women's Clubs has added eight areas of focus. I suggest Clubs learn about each area and support the area in your community, that you are interested in.

The eight areas are as follows:

CAMPUS SEXUAL ASSAULT

Campus sexual assault is any type of sexual contact or behavior that occurs on a school campus without the explicit consent of the recipient.

• CHILD ABUSE

Child abuse and neglect of a child under the age of 18 by a parent, caregiver, or another person in a custodial role that results in harm, potential for harm, or threat of harm to a child.

• ELDER ABUSE

Abuse later in life includes the physical, sexual, or psychological abuse, neglect, financial exploitation, or stalking of an adult age 50 years or older.

• HUMAN TRAFFICKING FOR SEXUAL PURPOSES

Sexual human trafficking is any act that has been induced by recruitment, harboring, transporting, provision, obtaining, patronizing or soliciting of a person for purposes of a sex act in which anything of values Is given to or received by any person.

INTIMATE PARTNER VIOLENCE

Intimate partner violence (IPV) includes physical, sexual, or emotional abuse, as well as sexual coercion and stalking by a current or former intimate partner. An intimate partner is a person with whom a person has or had a close personal or sexual relationship.

MILITARY SEXUAL ASSAULT

Military sexual assault is the use of force, threats, intimidation, or abuse of authority during sexual contact. It also includes instances where the survivor is unable to consent. Survivors of military sexual assault, include both men and women.

• TEEN DATING VIOLENCE

Teen dating violence (TDV)-also called intimate relationship violence or intimate partner violence among adolescents or adolescent relationship abuse-includes physical, psychological, or sexual abuse; harassment; or stalking of any person ages 12-18 in the context of a past or present romantic or consensual relationship.

The goal of the GFWC Junior Special Program: Advocates for Children is to be the voice for the young. To support them, so they grow up to be healthy and happy adults in our communities and continue a cycle of helping the generation below them.

Our younger generation, just as the rest of us, are recovering from the big hits of the last 2 years. Due to the isolation, we won't know the true impact it's had for some time. But we can continue to be there for them and find new ways to help.

Thankfully we live where there are many wonderful organizations created to help children in all parts of our state. We are a group of resourceful women that talk to the community and network with wonderful organizations within our community. This gives us insight on where big needs are.

Ideas to help and encourage the children in your community:

- Collect diapers and baby products (including larger diapers and pull-ups) for shelters and new mom organizations.
- Holiday giving tree's always have kids in need. These can be found through your city governments, churches, schools and foster resources.
- Reach out to schools and see what kind of assistance they need. Back-to-school time is tough for many, but the schools have further products needed mid-year.
- Help keep the kids fed through organizations and programs that offer afterschool snacks and meals.
- Find sports, arts, entertainment programs in your area and offer scholarships to be in their programs.
- Collect children's books for your local library, school program, pre-schools, etc.
- Connect with teen shelters and supply them with goods and services.
- With permission, put up flyers with resources to get out of harmful situations.

The Juniors' Special Program Advocates for Children encourages advocacy and projects that will assistand protect children in crisis, including those experiencing:

- child abuse
- depression, anxiety, and suicide
- foster, residential care, and homelessness
- hunger
- human trafficking

Helping children feel supported and cared for helps pass on the wonderful GFWC values of helping others. Which leads to a new generation to serve our wonderful communities we call home.

Our goal is to create projects that include crafts, dance, drama, food, music, and other manifestations of art and culture that develop skills, awareness, and appreciation. It is designed to inspire clubwomen and ignite within them a desire to make the world a more beautiful, thoughtful, and caring place.

Members of GFWC Washington State are eligible to submit items they have made to be judged at State Convention. (No food items, please!)

Photography, poetry, and short stories require a signed arts waiver.

The writing contest rules appear on pages 197 and 198.

Civic Engagement and Outreach

Civic Engagement and Outreach covers many areas of clubs involvement locally, regionally, nationally and globally. The areas of the Civic Engagement program are Citizenship, Crime Prevention, Safety, Disaster Preparedness, the Needy and Homeless, and our present Military and our Veterans. The following our suggestions in each program:

Citizenship covers getting out to vote, writing our legislators and congressmen with concerns. Having speakers from the League of Women Voters to speak or the Chamber of Commerce and maybe joining either one. Honor and celebrate patriotic holidays individually or with your club. Discuss the history of the American flag and how to treat it. Encourage club members and others to register to vote and help seniors and disabled to the polls.

Crime Prevention - Safety- and Disaster Preparedness Provide information to Seniors and others on the scams existing today and to watch out for individuals that participate in these acts. Facilitate CPR classes and Bicycle Safety Classes. Distribute information on the dangers of carbon monoxide poisonings. Have a speaker and information on Disaster Preparedness. Provide a list of emergency items needed in a disaster. Create a list of emergency phone numbers and information at who to call and when to call the particular numbers. The main emergency number 911 has changed and it is divided by priority so you may need another number. The number 811 is now a number to call for mental evaluation problems.

The Needy, Hungry, and Homeless – Volunteers are always needed at food banks, where you can donate food and recycle items such as grocery bags and egg cartons. Another need is providing meals and snacks for Habitat for Humanity workers who are building houses. Collect winter clothing, socks, backpacks for the homeless shelters. Work with programs that support meals to needy children. Provide and encourage clothing donations for students especially for special events, such as the Prom.

Our Military and our Veterans – Support the needs of the USO. Participate in Wreaths Across America and decorate the graves of our military during Memorial Day and Veterans Day with flags. Collect coupons to send to military families to use overseas. As women we need to honor our women veterans as well. Acknowledge the large rate of suicide among our veterans and look into how we can help. Ask a Suicide Prevention Coordinator from the VA Medical Centers to speak on how we can help. We can also contact the VA Medical Center on the needs of our women veterans and actually all the needs of the military. Find the needs of the military overseas and prepare boxes of food and specialty items to send to the troops.

Epsilon Sigma Omicron is an honorary educational society open to all GFWC Clubwoman. Over 80 years ago the ESO program became a permanent part of GFWC Education Department. Beta Chapter here in Washington State was the second state to form a chapter in 1930.

Join the Beta Chapter of ESO by submitting \$1.00 along with a request information letter. Include name, address, club, district, Email, phone and name of your local circle. Read a category of your choice at \$1.00 per category per administration. A brief report is given the local study director or sent to the state director and should contain title of the book, author, and the category title (again this year we are basing the categories on the community service areas) and brief statement about the book with your opinion. Reports are kept by your local study director, who forwards to the state director the list of books read. The state director will then send back a completed card with the credits on it. These can be kept by the member or in the study directors file. Books over 1000 pages count as three books.

Levels of membership

- Pledge You have paid your \$1 to join and are reading the first 4 categories of 10 books each.
- Member- Has completed 4 courses (40 books) and is eligible to wear the ESO pin.
- Star Level- Has completed 10 categories of 10 books (100 books) each.
- Torch Level- Has completed 16 categories of 10 books each (160 books). And they can wear the Greek torch pin attached to the membership pin. Once you have reached this level you can read the category of "member's choice".
- Century Level-Certificates are given for each 100 books (10 groups of 10 books) read. Members can continue on to the second, third century and beyond.
- Diamond Level- For every 1000 books read.

National GFWC encourages all state GFWC to protect and steward our earth by working to preserve our wildlife and domesticated animals, live sustainably, and beautify our community and enjoy nature. Washington State Challenge over the next 2 years every club plant at least 2 native trees in their community. This is important because all trees provide oxygen and decrease carbon in the atmosphere and provide shade and help decrease the temperature.

However, only native trees provide the following:

- Nutrients and needed food for our indigenous birds and animals
- Appropriate nesting sites and materials for our indigenous birds and animals
- The correct habitat for insects and spiders, the pollinators and food source for many plants and animals
- Don't need fertilizer and extra water because natives grow without those additions
- Better chance of survival and less work
- They are so beautiful

National target areas

1. Preserve Resources

Individuals can

- Plant natives to decrease water usage
- Offer excess native plants to friends
- Consolidate errands to decrease gasoline usage
- Decrease use of gas powered machinery (leaf blower)
- Purchase state and national park license plates to support Washington's parks
- Volunteer and support the work at Federation Forrest
- Contact your local elected representatives when you see that resources are going to be misused or destroyed

Clubs can

- Celebrate earth day by spending a day working in a local park to help clear out invasive plants
- Adapt a local park to help restore it to its former invasive free status
- Support financially local and state efforts to save the wild lands still available

- Volunteer as a group and adopt a local park for monthly habitat restoration parties

Disease awareness and prevention is the knowledge of the factors that cause a disease. This includes screenings, vaccinations, and shared information.

Nutrition is a key element in the quest of good health. Wise food choices, proper usage of vitamins and supplements, and food allergy awareness help maintain a healthy lifestyle.

Physical and emotional care includes physical, intellectual, emotional, spiritual, environmental, and social wellbeing.

A few facts from the Center for Disease Control and Mayo Clinic:

- 19.3% of the nation's children between 2-19 are obsese. Reasons: Poor nutrition habits and lack of physical activity.
- The risk of heart disease & stroke (2 of the leading causes of death in US) can be reduced with moderate-intensity aerobic activity
- Reduce your chance of diabetes & several types of cancer by having a fitness regimen.
- By having a regular fitness regimen, you will be sharpen your thinking, learning and judgment skills & reduce your risk of depression and anxiety as well sleep better.

GFWC Clubs are encouraged to plan a year-long project that will promote physical activity for any age group.



Communication is key to membership. Members need to be kept up to date on club meetings and events. Potential members want to know about your club. The more your community knows about your club activities the better you will do. There are many options to use in communicating. **Publicize your projects, events and meetings**. The GFWC Club Manual, which is online in the membership portal under resources. You can download/print the Communications Public Relations section, which is full of suggestions, techniques, and tips on how to be a professional communicator.

Newsletters are great for members and potential members. A **website** is a must in today's world. There are many free websites available. Be sure to connect it with the GFWC website. Facebook is another great source to get information out. You can have a page or a group. Use it to invite women to your club meeting or events. There is more information in the GFWC membership manual about apps that help you communicate with members and your community. Some apps that you can use include: TikTok, Instagram, Pinterest, YouTube, and Snapchat. Zoom, Google Drive and Slack are some of the apps that may help you in communicating.

Adapt your communications to your members. Not all members have or use computers. Phone calls and snail mail are always good to use for those without computers. Younger women like to use computers and social media to communicate so use a combination of methods to communicate with young and old. No matter what form of communication you use, make it interesting and informative. Communicate often.

 - An essay of no more than 250 words describing the club's/State Federation's approach to utilizing its newsletter

If your actions create a legacy that inspires others to dream more, learn more, do more and become more, then, you are an excellent leader. ~ Dolly Parton

In our daily lives, each of us are leaders. Every day we make decisions... what to wear, where to go, when to eat. In addition, in our club lives, we are also leaders... what project your club will pursue, or how you will fundraise for your local charities. No matter how small a decision may seem, this is leadership. As a leader, you set the example for those around you and take on the responsibility that comes with this role.

As described in the GFWC Club Manual for 2022-2024, there are seven acts of everyday leaders:

• Commit. Passion is a strong desire that can get you to do amazing things. Passion is an emotion to be acted upon. Without action, passion yields no worthwhile results. When you have passion for something, you love it even when you hate it.

• Listen. Everyday leaders engage their power of listening; listen more than you speak. Listen to experts, fellow enthusiasts, and your members; including those you disagree with. Absorb their perspectives, insights, and experiences.

• Communicate. You have feelings, experiences, opinions, and a voice. All have value. So, share them often. You become an everyday leader by expressing your thoughts and ideas. Even hair-brained, way-out-there input from you is better than silence.

• Be humble. We all know so-called leaders who are described as arrogant, entitled, and controlling. Do not be that leader! See yourself as an everyday person whose experiences and voice matter as much as the next person's – no more and no less than your neighbor's.

• Innovate. There are formulas for everything, and they are copied and followed. You do not have to shock and awe every chance you get but think about offering something fresh to further the conversation or something original to move the ball.

• Learn. If you are human, you have failed. Failure, however, is not an end to the story, it is a beginning. The trick is to "Fail Forward." What did you learn, and what will you change next time? Then, get back up and keep moving forward.

• Smile! Your smile can change the world. It is a powerful tool. Your smile brings hope, light, acceptance, and gratitude.

The future of our State, your district and/or your club depends on the quality of leadership that exists within your club. Good leaders are always looking for ways to build, encourage, and promote, new,

upcoming leaders. New leadership brings with it new and exciting challenges opportunities, projects, and programs.

For annual report writing, hours should include attending District and State meetings as well as the many hours you spend working to make your club the best it can be. Let your narrative tell your club leadership story.

Other suggestions:

- Ask those who have participated and attended federation events to report at the next meeting and to do it enthusiastically. This will encourage others.
- Appoint a leadership chairman for your club and ask her to bring leadership ideas and encouragement to each meeting.
- Introduce your members to Robert and leverage parliamentary procedure to keep meetings on track.
- Have your club design, create, and print business cards for every single member. The cards can provide a name, address, phone, as well as email and website. The cards are an effective tool for networking, soliciting donations and sponsors, and recruiting members.
- Encourage and utilize the many written resources available to our members. The GFWC Club Manual and quarterly Clubwoman Magazine; the GFWC-WS Administrative Handbook, the GFWC-WS Clubwoman, district newsletters, club newsletters, reports, and histories: all have valuable information. Consider reviewing them as a club project.

At all costs, understand you are not alone and our state has many strong, excellent examples and members at your disposal, merely for the asking. Multiple past State Presidents, past District Presidents, and even our very own past International President. We are all here with the same goals and love of Federation.

GFWC-WS Leadership Education and Development Seminar (LEADS)

The GFWC Leadership Education and Development Seminar (LEADS) program is intended to identify GFWC members at the local level who have the potential and the desire to assume leadership positions in our State Federation and/or GFWC beyond our state. Participation in GFWC LEADS can help up-and-coming leaders gain the capabilities, confidence, and commitment necessary to pursue and achieve higher office and serve with distinction. GFWC Washington State selects one LEADS attendee each year. GFWC LEADS is held annually the day before the official opening of the GFWC Annual Convention. The program may include an overview of various leadership skills; an explanation of GFWC resources, materials, and assistance; an outline of GFWC policies, procedure, and protocol; and discussions of tips and techniques for pursuing personal growth and developing leadership opportunities. Criteria for LEADS Participation: LEADS candidates should meet the following criteria:

- Demonstrates leadership capabilities at the club level as an active club president, club
- officer, or club project or committee chairman
- Exhibits a commitment to the Federation
- Exhibits an understanding of the GFWC mission of community service, illustrated by programs and projects in which she is or has been involved
- Demonstrates leadership skills, including, but not limited to, organization, responsibility, trustworthiness, enthusiasm, and flexibility
- Exhibits an interest in and willingness to pursue higher leadership positions in GFWC
- Agrees to share information gained from participation in LEADS with others in GFWC-WS and make an effort to attend and share at the Fall GFWC WSR region conference.
- Has not held elected positions at or beyond the state level
- Is a current dues paying member and has not attended a previous LEADS program.

LEADS attendees are expected to be responsible for a portion of their expenses as an affirmation of their personal commitment and are responsible for making their own travel and lodging arrangements.

LEADS attendees receive:

- Transportation and lodging stipend of \$325.00 from GFWC.
- Lunch during the LEADS program (no registration fee is required)
- Checks will be distributed to candidates upon completion of the seminar.
- Additional travel stipend of \$200 from GFWC-WS.

The United Nations Refugee Agency

Ref-u-gee: a noun – a person who has been forced to leave their country in order to escape war, persecution, or natural disaster.

In 2022 the staggering number of 100 million people around the world now fit this definition of refugee. This number represents families and individuals who were forced to leave behind their homes, the communities they are a part of, friends and extended families, and the life they knew. This number of refugees are a challenge for everyone.

USA for UNHCR, the United Nations refugee agency is working daily to deliver protection for refugees and helping to empower them with hope and opportunities. However, they need our help.

UNHCR resources need an immediate boost to continue to provide the needs of this staggering number of refugees. Their goal is to raise \$100 million by World Refugee Day 2023. They are reaching out to key partners to help in the initiative.

Find fun and innovative ways to raise funds for UNHCAR. Place an op-ed in your local newspaper regarding the refugee situation around the world. Make your local community aware of the overpowering need for assistance with the refugee situation worldwide. Contact local organizations that are working with refugees in your community and see what their needs are for the displaced families. Helping a family get set up in a new home is a wonderful gift when you are trying to make a new start.

Seventy percent (70%) of refugees are women and children. Eighty-three percent (83%) are hosted by low and middle-income countries. 350,000-400,000 children are born as refugees each year. They need our help to "STAND WITH THE 100 MILLION."

You will have an opportunity to hear more about UNHCR throughout this administration. I look forward to hearing about your projects as you reach out a helping hand to the world refugees.

Reporting Rules

Using the Official GFWC Washington State Reporting Form will help calculate the statistical information from all the clubs in our state. You must use the official reporting form when reporting if you wish to be considered for awards. This form will be available prior to reporting deadline.

Narratives – are important for they give valuable information about your projects not found on the statistical form. You must submit one narrative for each area you are reporting in if you wish to be considered for awards.

Cross Reporting – IS NOT ALLOWED!! Find the best spot to report your club's efforts and do not repeat on either the statistical report or in the narratives.

Can individual member's efforts be reported? The simple answer is NO! The only way you can legally honestly report individual member's efforts is to have that member ask the club to support. Support means: either a financial donation from the club's treasury or the enlistment of additional member's time and talents to help with a project. Additionally – your club must vote to make these "individual" efforts a "club" effort – or reporting it is just plain "fudging" your reports.

Please share this information with all your officers and chairmen.

Outstanding Clubwoman of the Year

This award, the GFWC-WS Club Woman of the Year, is to honor and recognize the State club woman and volunteer who demonstrates the GFWC philosophy of community improvement through volunteer service; "Living the Volunteer Spirit."

Each club may select one member to be honored. A report must be turned in by March 1st of the current year describing the candidate's activities from January 1st through December 31st of the previous year.

Three copies of this report must be submitted since there are three judges involved. You may use non GFWC members as judges; however, it is acceptable to choose members from within the State club. The report must include the following:

Cover page:

- 1. Candidate's name
- 2. Club
- 3. District
- 4. Club President's signature

Narrative containing no more than 2 pages typed should include:

- 1. Brief description of Federation activities prior to last year
- 2. Detailed description of current GFWC activities
- 3. Brief description of State, District, and club
- 4. Brief description of community activities outside club
- 5. Brief description of family and professional life

Eligibility: Candidate must be a due's paying member of GFWC-WS to be considered. Currently elected GFWC-WS Officers and past GFWC-WS Presidents will not be eligible for this award.

The Charlotte Gyllenburg Contest

Contact: Cindy Bassage, GFWC-WS Vice President

The **Charlotte Gyllenburg Contest** began in 1951 with Washington State Junior Clubs, named in honor of Charlotte Gyllenburg, the first Washington State Junior President (Director of Junior Clubs). The perpetual award, presented biannually at State Convention in even years, is a sterling silver tray. It is engraved with the names of the Junior Clubs that received this award until Washington's Junior Members merged with the General Membership.

CRITERIA: A single outstanding Community Service Project.

Reports must contain the following:

Need of Project (45%) – Need shall be interpreted as a project being of great benefit to the community.

Accomplishment of Project (35%) – Accomplishment shall be determined by:

- 1. Club hours spent.
- 2. Money spent or collected. (Actual money spent, not the estimated value of project.)
- 3. Outside assistance. (Clearly specify.)
- 4. Number of members participating on project.
- 5. If it is a continuing project, clearly show the current two years' work.

Permanency of Project (20%) – Permanency shall be interpreted as continuance of the project, or continuance of the benefit from the project; i.e., sponsoring a swimming class would be more permanent than purchasing an object for a swimming class.

Rules:

- 1. Each club can enter only one project.
- 2. The reporting period is January 1, 2020 through December 31, 2021.
- 3. The report shall not exceed 2 pages (one side only), 81/2" x 11", typed, single-spaced.
- 4. Reports shall not be placed in a folder
- 5. Send three (3) copies of the report to the GFWC Washington State Vice President (address above).

Judging: The current GFWC-Washington State Vice President will serve as chairman of this contest, assisted by two past presidents. Late reports will be disqualified

Jennie Award

The GFWC Jennie Award honors one clubwoman from each GFWC Region for outstanding commitment to club, community, and family.

They are chosen by their clubs to compete at state, region, and national levels for the Federation's highest honor.

The Jennie Award is named in honor of GFWC's founder, Jane Cunningham Croly, who wrote for national newspapers under the fictitious name "Jennie June." The award is an occasion to highlight extraordinary clubwomen who exemplifies her spirit of independence, courage, and persistence in purpose through their roles as volunteers within their clubs, elsewhere in the community, and as members of a family or extended family. Although GFWC has many awards for states and clubs, the GFWC Jennie Award is the only national honor that recognizes individual members for personal excellence.

Since it is an award for lifetime personal excellence, club presidents should consider utilizing the knowledge of club historians for Jennie Award nominees. Club presidents should be mindful of first impressions and make the nominee's packet of supporting materials as professional as possible because it may be judged at the different levels by influential community leaders.

Award Rules

- Clubs may nominate one member who has demonstrated the qualities outline under the judging criteria for this award.
- Nominee must be a member in good standing of a GFWC club for a minimum of five years. Her tenure of service may be with several clubs. Years of service must be consecutive not concurrent.
- Current and past members of the GFWC Executive Committee are ineligible.
- Nominations should emphasize a member's entire lifetime of service.
- Clubs must complete and submit the official GFWC Jennie Award Nomination Form along with a maximum 500-word written narrative. Narratives should include descriptions of the nominee's:
 - Club activities
 - Participation in community groups and organizations, both volunteer and professional
 - Commitment to her nuclear or extended family
- Clubs must submit the following supportive materials along with nomination form and narrative:
 - Photograph of nominees (no larger than 5x7 inches)

- Clips of two-three newspaper (or other media) stories about successful projects
- To which the member contributed (it is not necessary for such articles to mention the member by name).
- Letter of endorsement from club President
- Letter of endorsement from a representative of another organization
- Nomination forms and supporting materials, including photographs, will not be returned.
- Clubs must submit nomination materials to Susan Tyler, GFWC Washington State President, postmarked by June 1, 2021, for state level judging.

We have so many deserving women in Washington State, that each club should consider nominating a member of their club for this outstanding award.

Scholarship awards play an important part in GFWC. Many deserving students anticipate receiving a scholarship to help finance their college education. The Education Scholarship Committee encourages each member, club, and district to consider making a monetary contribution to the Scholarship Fund for the future funding of the state's scholarship candidates. Your contribution to the GFWC – WS Scholarship Fund may be submitted using the Dues and Contributions Form in the Administration Handbook. All contributions are sent to the GFWC-WS Treasurer – Kimberly Skagen.

Adding the Scholarship Fund as a line item on your club or district budget is a good way to remember to make a contribution. Special Event Fundraising raises awareness for the need to keep nurturing young women to attend college. Reach out in your communities to your local schools to recruit candidates for the scholarship awards.

Educational Scholarship Guidelines (non-Member)

To Club Presidents and Scholarship Chairmen:

ALL requirements must be met; incomplete applications will not be considered.

- 1. The minimum amount to be awarded by the state, per scholarship, is \$250. Individual clubs and districts are not required to award a scholarship in order for a candidate to be eligible for the state scholarship. Clubs are encouraged to make an annual contribution to the state's scholarship fund as explained above.
- 2. The top recipient will also receive the Kathy Estep Memorial Scholarship.
- 3. There is no **club cut-off date** on the form; we **suggest February 1st** in order to give your club time to select your applicant.
- 4. Only one (1) candidate entry per club.
- 5. A personal letter stating **goals**, financial need, future plans and additional pertinent information-
- 6. Three (3) letters of recommendation.
- 7. A **club letter** should be included showing evidence the sponsoring club knows and supports its candidate.
- 8. The original application should be **signed in ink by the Club President or Scholarship Chairman**.
- 9. Three (3) copies of the application, letters and transcript are to be mailed to Rena Johnston. Only one photo is necessary.
- 10. Applications must be **postmarked no later than March 1. Late applications will not be considered**.
- 11. **Final decisions** will be made by the GFWC-WS Educational Scholarship Committee on the basis of the information furnished,
- 12. Scholarship awards must be used in an accredited school in Washington State.
- 13. Scholarship money will be sent to the school in which the recipient is enrolled **after verification** is received by the GFWC-WS Financial Secretary.

Member Scholarship Guidelines

The GFWC-WS Member Scholarship shall consist of accrued interest from funds presented to the state federation at the dissolution of the GFWC-Washington State Junior Membership plus gifts, if sodesignated.

The Educational Scholarship Fund trustees shall determine the recipient and amount of the scholarship with approval of the Board of Directors; an amount not to exceed the accrued interest plus gifts may be awarded.

- 1. Applicants must be active members in good standing of a GFWC-WS club.
- 2. A club may submit no more than one applicant.
- 3. Each entry must be on a current application form and signed in ink by a club official.
- 4. Applicants must be a resident of the State of Washington.
- 5. Applicants must include the following:
 - a. The current GFWC-WS scholarship application form.

- b. A small photo (approximately 2" x 3") for publicity.
- c. A personal letter stating goals, financial need, future plans and additional information.
- d. Three (3) letters of recommendation.
- e. A personal letter from the sponsoring club stating support of the applicant and signed by a club official.
- 6. Three (3) complete copies of the application and all materials are to be mailed to Rena Johnston.
- 7. Applications must be postmarked to the GFWC-WS Educational Scholarship Chairman by MARCH 1.
- 8. Applications received incomplete or after the due date will not be considered.
- 9. Final decisions will be made by the GFWC-WS Educational Scholarship Committee on the basis of the information furnished. No more than one (1) member scholarship shall be awarded each year.
- 10. Scholarship awards must be used in an accredited school in Washington State.
- 11. Scholarship money will be sent to the school in which the recipient is enrolled after verification is received by the GFWC-WSF in ancial Secretary.

Recipient must maintain an active membership in a GFWC-WS club during the terms for which the scholarship/tuition monies are applied.

Members of the committee are Char Lysne and Sally Larson. Our responsibilities include:

- maintaining a good working relationship with park management team and participating in planning for park improvements at the invitation of the park's management team
- keeping GFWC-WS membership advised of the status and condition of the park as well as our committee activities
- having knowledge of the park's history and GFWC-WS
- traveling to the park's location for dedicated events or at least once a year
- advocating for the park.

Federation Forest State Park has continued as a GFWC-WS project since 1926 when our first fundraising campaign was launched to purchase the original park site along Snoqualmie Pass. The deed for that property was presented to Washington State Parks and Recreation in 1928. First park location opened in 1934 and was forced to close in 1938 after a windstorm blew over many of the trees and the park was declared a disaster. That property was sold, and the sale money held in trust until another suitable location could be found. The park at this location, along SR-410, opened July 16, 1949. The Catherine Montgomery Interpretative Center opened in 1964. Catherine Montgomery was a GFWC-WS member and founding faculty member at Western Washington University. She left her estate to GFWC-WS to be used for educational purposes at the park and those funds were used to build the interpretive center. Exhibits in the center were updated in 2016 and in May 2022 GFWC-WS donated a quilt made by members and it is now hanging on a wall in the center. We have not wavered in our support of the park through the years by advocating for preservation of the park, purchasing needed equipment and supplies, and performing volunteer work at the park.

<u>Please include a club and district budget line item for a donation to the GFWC-WS Federation Forest</u> <u>Fund</u>. Donations are sent to GFWC-WS Treasurer, Pinkie Eggleston when you send in your dues.

We encourage you to visit the park and bring your friends and family. It is a place of peace, beauty and tranquility that will capture the hearts of nature lovers who visit.

Resolutions are important because they establish the general policy of GFWC-Washington State. Before a club can advocate for or against an issue, a written resolution must have been passed by our state or GFWC International.

Resolutions can be sent to the Resolutions Committee Chairman by a club, district, the Board of Directors, Executive Committee, a Community Service Program Chairman or the Resolutions Committee.

Proposed resolutions are to be sent to the Resolutions Committee Chairman by December 10.

Resolutions begin with a general statement of fact – WHEREAS, then move to the desired actions to be taken by our organization. - RESOLVED, That GFWC–Washington State

There can be more than one whereas and more than one resolved. Each paragraph ends with a semicolon and, in the case of the next-to-last paragraph, the word "and."

The proposed resolution will be reviewed by the committee and presented at the state convention. Resolutions, except emergency resolutions, which are presented to the convention shall be published in the Call to Convention.

All resolutions which have been in force for four years shall be automatically reviewed by the Resolutions Committee members.

Responsibility for carrying out the intent of the resolutions rests with the President of GFWC-Washington State, the chairman whose work is germane, the chairman of Legislation and member clubs.

What are Bylaws?

Robert's Rules of Order Newly Revised (RONR), 12th edition, Section 2.8 defines bylaws as the document of a society that contains its own basic rules relating principally to itself as an organization.

The bylaws define the primary characteristics of the organization, prescribe how the society functions, and includes all the rules that the society considers so important that they cannot be changed without previous notice and the vote of a large majority and cannot be suspended.

What the GFWC-Washington State Bylaws say about the Bylaws Committee.

Article VIII – COPMMITTEES

B. Bylaws Committee. The Bylaws Committee shall consist of a chairman and two members. The Parliamentary Advisor shall serve as an advisor to the committee. Its duties shall be to:

1. Annually consider and edit proposed amendments and recommendations for amendments to the Bylaws and Standing Rules as outlined in Article XVI.

2. Prepare all proposed amendments to the Bylaws and Standing Rules for inclusion in the annual Call to Convention.

3. Present all proposed amendments to the Bylaws and Standing Rules to the Board of Directors for appraisal and to the convention body for action.

What the GFWC-Washington State Bylaws say about amendments to the Bylaws:

ARTICLE XVI – AMENDMENTS

Section 16.1. Amendments to these bylaws may be adopted at the Annual Convention by a two-thirds (2/3) vote of the members present and voting, provided the proposed amendment was appended to the Call to Convention. Amendments may be proposed by <u>GFWC-WS elected officers</u>, the Board of <u>Directors, Executive Committee</u>, Bylaws Committee, or any district or member club. Proposed amendments shall be sent to the President and to the Bylaws Committee Chairman by December 1. All proposed amendments shall be stated in the Call to Convention, considered by the Board of Directors and presented to the convention by the Bylaws Committee.

It is important to remember that when proposing an amendment to the Bylaws, to state the exact wording that is being proposed along with all the of Articles and Sections to be affected by the amendment. Also include the reason for the proposed change.

The Bylaws Committee looks forward to working with each of you as together we work to enhance to GFWC-Washington State Bylaws.

The Nominating Committee is a Standing Committee of GFWC-WS according to Article VIII, Section 8.1,J.

"The Nominating Committee shall consist of five members, who shall be nominated from, and elected by, members of the GFWC-WS Board of Directors at the post-Convention meeting in even-numbered years. No district shall have more than one member on the committee, and the committee shall elect a chairman following their election. Duties of the committee shall be to:

- Request names and endorsements of qualified candidates, authorized at a regular or special district meeting, from districts and recruit qualified candidates to fill the slate.
- Require district endorsement letters, with the candidate's picture and letter of consent, to be submitted to the Nominating Committee Chairman by November 15 of the odd-numbered years.
- Verify that candidates have met the requirements for office and notify their sponsoring districts and the GFWC-WS President of the slate of nominees.
- Send slate of nominees, with photos and bios including the President-elect's, to the Washington Clubwoman for publication in the issue prior to the election.
- Present the slate of nominees to the convention body in the even-numbered years.".

To fulfill these responsibilities, the members of the committee will be working with each of the five districts in Washington State to encourage an endorsement for each of the offices to be elected. If you or someone you know is interested in seeking a Washington State office, please contact the representative from your district. She will be more than happy to assist you with the process of endorsement and verifying a candidate's qualifications.

What is an Endowment?

(GFWC Washington State Bylaws, Article X – Endowment Fund)

To remain aligned with the GFWC Washington State "Strategic Plan", our membership needs to use this plan to guide and strengthen the activities of our organization. By using these goals and strategies, our organization will be able to plan efficiently for the future. By focusing on the achievement of objectives within the "Strategic Plan", we are also charged with working to increase the financial stability of the GFWC Washington State Vision. It is the responsibility of every GFWC Washington State member to support and promote the <u>visions and objectives</u> as stated in the "Strategic Plan". Ella Dietz Clymer, President of Sorosis, addressed delegates at the 1889 organizational meeting calling together members of women's club. "We look for unity, but unity in diversity. We hope that you will enrich us by your varied experience and let us pledge ourselves to work for a common cause of united womanhood throughout the world". Her memorable phrase, "Unity in Diversity," was adopted as the official motto of the General Federation in 1957.

EMBLEM

The General Federation had not long been underway when the question arose as to what distinguishing emblem its members should wear so as to recognize one another. Dr. Leila G. Bedell of the Chicago Women's Club recommended at the 1892 convention that "some simple badge be designed which all could procure and wear.

A committee was named with Jane Cunningham Croly, GFWC founder, Charlotte Emerson Brown, first GFWC President; and Jennie de la M. Lozier, of Sorosis, as members. They chose a design that incorporated a rising sun as the symbol. There is no record that the design was ever endorsed by either the convention or board of directors, but when the Council met in 1893, the pin was already in distribution. The pin blue and silver with background of terra cotta.

When Alice Ames Winter became President in 1920, she was dissatisfied with the rising sun symbol saying, "We decided that the sun had risen and that the time had come" for a new emblem that more nearly represented the mature organization. Accordingly, a new design submitted by Douglas

Donaldson, was approved in 1920. The sign shows a crusader's shield, signifying enlightenment, emerging form the darkened world, which is represented by a black center; the band encircling the center signifies eternity; a fully risen sun on a field of blue, for purity and blue for constancy – surrounded by the letters GFWC and the motto Unity in Diversity.


A new tagline contest began in July, 2012. Members were asked to submit their choices for a replacement for the current tagline *GFWC-It's A Volunteer Thing!* which had served the organization well when it was introduced at the International Convention in 1983. On April 6, 2013, the new tagline was announced that *Living the Volunteer Spirit* won the contest. GFWC thinks the new tagline reflects the personality and commitment to service you show each day in your communities.

FEDERATION FLOWER

The red rose was officially adopted at the Council Meeting in Milwaukee, Wisconsin, May, 1940. It was selected from suggestions sent in by various clubs.

FEDERATION COLOR

A May 9, 1893 report indicated that the color blue, signifying constancy, was chosen by Charlotte Emerson Brown and Jennie June Croly.







<u>SONG</u>

In 1922, Katherine Lee Bates' "America, The Beautiful" was chosen because it is a song of dignity and beauty, easily sung, and reflecting the true spirit of America and the ideals of the Federation.

Explanation of the GFWC Emblem

The emblem of the General Federation of Women's Club is a thing of beauty and significance.

The Black background represents the "Darkness of Ignorance."



The Crusader's Shield on the black field signifies enlightenment, "women emerging from the shadow of ignorance."

Each of the three colors of the Shield has a special meaning -

- The RED is for the Courage of the women who accept the responsibility of membership in an organization dedicated to service.
- The <u>WHITE</u> suggests the <u>purity</u> which is woman's most effective weapon in her crusade of the advancement.
- The <u>BLUE</u> represents <u>constancy</u> which enables her to remain steadfast to her noble purposes.

The lettering on the circle of White stands for "General Federation of Women's Clubs."

The outer, unbroken circle suggests "For All Eternity." The Circle has no beginning and no end. All arts are fused together to form one perfect and harmonious whole.

The motto, "Unity in Diversity", describes a united band of women struggling eternally for the causes in which they believe.

Biographical Sketch of Mary Stewart

Mary Stewart was born in Ohio, but at an early age moved to Georgetown, Colorado, where she lived until she entered the University of Colorado at Boulder. She was a graduate from this university with a B. A. degree and in 1927 received the honorary degree of Master of Literature.

Her first position was that of principal of the high school at Longmont, Colorado. It was at this time that she became associated with the General Federation of Women's Clubs. For eight years she served as Dean of Women at the University of Montana, where she also taught Latin and English.

After 1921 – Miss Stewart's work was with the United States Government. She became Assistant Director General of the United States Employment Service, Department of Labor, and from 1928 until

January 1942, served as Assistant Director of Education in the Office of Indian Affairs, Department of the Interior.

Mary Stewart died in Cincinnati on April 1, 1943.

Presented to Washington State Federation of Women's Club's by Spokane Sorosis in the year 1896

Once upon a time some thirty years ago a meeting of organization, for the Washington State Federation of Women's Clubs, was held in the City of Tacoma.

Perhaps no one of the twenty-two clubs had felt the importance of this occasion more than Spokane Sorosis, and it was her happy thought, to provide a gavel to be presented to the Federation. We are certain the form and historical significance of the Gift, had its origin in the mind of a most active Sorosis member – Esther Allen Jobes – anyway, we as a club, followed out the suggestion, that it be a carved representation of the Apple – its branch – and foliage.

Rosine Edwards – descendant of the great Jonathan Edwards – while sojourning in Walla Walla, obtained for us the portion desired, from one of the apple trees planted by Marcus Whitman, at the mission station of Waiilatpui. Acting as Club artist, it now remained for me to select, from some Spokane apple tree, the branch from which to make the design. My choice was one from the old Ridpath home, sixth and Washington, owned by Col. Ridpath – brother of the eminent historian. The design next passed to Alix Ostergrin, a Swiss woodcarver of skill, at that time instructor in the Spokane Art League. On completion of his work, we had but to add the silver plate, and our Gavel was done.

Mrs. Jobes, though taking a needed rest after a trip around the World, kindly wrote us in regards to the presentation and I quote her words: "Mrs. Schiller and I were delegates from Spokane Sorosis to the organization meeting, and all I did was to make this gavel presentation speech. The minute our first State President took the chair following her election, - I remember how frightened I was, dreading to say a word before so many people, but dear Mrs. Amy C. Stacy the new President, was so delighted, and the Federation, numbering twenty two clubs, expressed thanks to Spokane Sorosis, "for the handsome Gavel", - and then Mrs. Jobes adds – "I have seen many gavels since then, but not one as beautiful as ours."

Dear Federation, thirty years have brought you <u>strength</u> from <u>many sources</u>, until your influence for good, is felt over the entire State. Surely the <u>Apple</u> – that masterpiece of nature – is symbolic of our organization, for did not complicated forces work together to produce it? For years the tree grew from seed, to trunk and branches, bursting into bloom and bud in May the sap next flavored the fruit with sugar, and spiced it with wine. The breezes fanned it; the showers baptized it; the sun kissed it; and the frost mellowed it. It distilled its most delicate flavors from the dew and caught its colors from rainbows and sunsets. Earth and Sun watched over it, and the Solar system cradled it, in its care. The Apple literally became a center of the universe, and all the stars revolved around it. No wonder that it comes to us as one of the choicest gifts of nature, after such toil and care, and with such virtues and graces, as have been lavished upon it. With its health-giving, and its drawing people into comradeship and fellowship, it is but <u>another power</u> bringing gladness into many homes, and this is why today, we dare to tell the – <u>STORY OF THE GAVEL</u>

The History of the Gavel Box

THE GAVEL BOX IS THE GIFT OF MRS. ELLA HIGGINSON, of Bellingham, Washington, a poet of local and national fame, an author, a lover of fine music and the honorary member of the Washington State Federation of Women's Club. At the state convention June 17, 1931, she was crowned Poet Laureate of the State Federation.

Mrs. Higginson, through her poems, gave poetic realism to the wonders of nature. Her love of trees was exemplified in the inspiration which conceived the lines for "I Cannot Take My Hemlocks," the initial poem of the "Ella Higginson" tribute published by the State Federation. She garnered inspiration and joy from her beloved grove of native trees, an arboreal haven, which shaded her home.

In her house on picturesque Sehome Hill, the Rose Room was finished with the heartwood of the Purpleheart tree from the Amazon.

Understandable it is, then that her poetic soul should quicken to the sight and interesting history of the beautiful wooden carving, the gavel of the Washington State Federation of Women's Clubs.

It became important to her that there should be an appropriate box where it might rest when not in use.

It was her cherished desire to have presentation made during rhe presidency of her very dear friend, Mrs. Kate Turner Holmes, second president of Washington State Federation of Women's Clubs, who came to visit her frequently when the only means of transportation was by side-wheeler.

Following the convention of the year 1899, held in the city of Seattle, the talents of Mrs. Frances Axtell of Bellingham, then a professional wood carver, who went on from craftsmanship in woodcarving to distinguished accomplishments in citizenship, were solicited for the project. These were Mrs. Higginson's words when she called at Mrs. Axtell's home one day so long ago, "I would like to present a suitable gavel box to the State Federation with the understanding that if the federation should disband the box would become the property of Mrs. Holmes. Since you are so greatly interested in federation work, will you design and carve the box?"

The request was honored. Inspiration for the design to be carved came from Mrs. Higginson's poem, "The Four Leaf Clover," the words of which had been previously adopted as lyrics for the Federation song and in keeping with the acceptance of the four leaf clover as the Federation emblem. A Washington Oak tree gave of its durable wood.

The presentation was made May 29, 1900, at North Yakima. Mrs. Higginson's versioned gift to the Federation, the historic gavel box, embellished with exquisitely carved four-leaf clovers, had become a reality. In her letter of presentation she spoke of its being made of Washington Oak, carved by a Washington wood carver, and donated by one who is proud to call herself a Washington woman: "The Federation has and always will have, my warmest wishes for its success and long life," were the words with which she expressed her feelings for the Federation.

At the dawn of the century we were pioneer women in a new country who believed that women through organization could do much for women, for civilization and for the western world. We were looking forward, not backward!

The gavel and box are now history and will continue to remain in the safe keeping of each succeeding president. Once more, able hands will use them to call to order the meetings of the Washington State Federation of Women's Clubs to make and carry out plans for a better state, a better America and a better world.

May this gift from the gifted ever symbolize an enduring message:

"You must have hope, and you must have faith, You must love and be strong – and so – If you work, if you wait, you will find the place Where the four-leaf clovers grow." Ella Higginson

This revision of the history of the gavel box is presented by the P.L.F. Club of Bellingham of which Mrs. Ella Higginson was an honorary member for nearly a half century.

Mrs. Frances Axtell became the club's first president in September of 1900.

The Story of Federation Forest



WHO'S THE "FEDERATION" BEHIND THE NAME FEDERATION FOREST STATE PARK?

It's the General Federation of Women's Clubs of Washington State. And here's how this park became a reality: Back in the mid-1920s, saving a sample of great trees for future generations was the idea of Jeanne Caithness Greenlee, an Everett High School teacher and a member of Washington State Federation of Women's Clubs, now General Federation of Women's Clubs (GFWC). Miss Caithness had witnessed the destruction of the mighty forests in her home state of Wisconsin and did not wish the same fate for our majestic stands of tall, old trees here in Washington State.

During the 1925-1927 administration of our 16th State President Mrs. Ester Maltby, Miss Caithness (aka Tree Lady) the Forestry Chairman, proposed a state project to purchase and preserve a stand of mighty old trees in a park setting for all people to enjoy.

It took about two years for clubwomen to raise \$25,000 to purchase from a lumber company the 62.89 acres tract of giant firs, cedars, and hemlocks on the western slope of Snoqualmie Pass, eight miles down from the summit. Dedication of the park was delayed until the new transcontinental road was completed through this tract and was held in 1934 during the term of our State President Mrs. E. E. Corwin. It was a festive occasion with visiting dignitaries from all over the country and speeches by

Mrs. Jeanne Caithness Greenlee and Mrs. Maltby. Misfortune descended upon the park in earnest. Necessary slash burning on the west boundary got out of hand in hot September weather and hopelessly charred some of the finest specimens; the widening of the highway had taken its toll on the trees; and a bad wind storm brought down a number of trees. The Highway Department instructed the Parks Department to top of number of the most spectacular trees. Due to an inadvertent trespass by a logging company on the east side, twenty-two of the mightiest giants were harvested, most of which were over one thousand years old. The state was compensated a mere \$1,000 for this timber. The final blow was a windstorm on December 2, 1938, which blew down nineteen trees, a few across the highway. The Parks Department was ordered to cut back all trees for two hundred feet on each side of the roadway. That was just too much for the park to withstand and the Chairman of the State Parks Commission advised the Federation to give its consent to selling the tract back to the lumber company, as had been agreed in the deed, should any disaster overtake the transaction. A bill was immediately passed by the Legislature placing that \$25,000 in a new fund with which to buy a new Federation Grove.

In 1941 Mrs. Belle Reeves, who had served as a Legislator and Secretary of State and was now Chairman of the State Parks Commission, learned of 220+ acres of young growth on the Chinook Pass. However, the west boundary cut through some of the best trees and should the timber company who owned the adjacent land cut down their trees, this would leave the new stand of trees exposed to harsh winds, with the possibility of the same fate as the first park.


Through a stoke of good luck, Mr. Otto Case, State Land Commissioner and a friend of Federation, recalled a much-contested early ruling which set aside a small percentage of the gasoline tax in its early years for roadside protection of the highways. After consulting the Attorney General, it was determined that it would be legal to allocate some of that fund to the protection of the State's own forest exhibit, if a properly prepared bill was passed by the Legislature. The bill was written by Mr. Case and the Attorney General and with the presence of a large number of Federated Clubwomen, it passed. This provided \$125,000 for 314 more acres which should provide an excellent barrier to mischievous western breezes.

The new location for the park is located fifteen miles past Enumclaw on the mountain road leading to the summit of Chinook Pass. It is on the White River, which has its source in Emmons Glacier. For more than three miles the highway passes through Federation Forest. Dedication of the new park took place July 16, 1949, with much fanfare and past Federation State President, Mrs. E. E. Corwin, announced that the Board of the Washington State Federation of Women's Clubs had voted to honor Mrs. Ester Maltby by dedicating to her a trail in this grove, whereon should be erected a bench of native stone so that any who trod that way might rest and meditate in this peaceful place.

Miss Catherine Montgomery, an educator at Western Washington University, an avid outdoors woman and a Clubwoman deeded 2.25 acres to Federation Forest State Park November 16, 1951. Upon her passing in 1957, she left her entire estate to Washington State Federation of Women's Clubs for the improvement of the park. The Catherine Montgomery Interpretive Center was constructed with a large portion of these funds. Through the year's additional funds from her gift, along with donations from clubs and individual club members throughout the state, have been spent for equipment and improvements at the park. An additional 60.5 acres was deeded to the park from the Department of Natural Resources November 29, 1971, bringing the total acreage to 619 acres. The General Federation of Women's Clubs of Washington State maintains a watchful eye over preservation and funding issues for the park. Clubs visit the park to perform volunteer work, especially helping to maintain the interpretive garden beds outside the Catherine Montgomery Interpretive Center.

The web site tells us that the rest of the park is a day-use natural area. Visitors can enjoy the beauty and diversity of 600 acres of old growth Douglas Firs, with mature Western Hemlock, Sitka Spruce and Western Red Cedar trees. Visitors can hike through five distinct ecosystems within a radius of just one mile. There are short interpretive loops that make this an ideal experience for small children. A fun place in the park is the Hobbit Village with small huts, wee tables and chairs and micro gardens.
